NOW THIS DEED OF DECLARATION OF TRUST WITNESSETH THAT:


I. HISTORY:

Whereas Sri Raghavendra Swamiji, a great spiritual leader and 17th peetadhipathi in the illustrious line of succession of Sri Madhvacharya, propounder of Dwaita philosophical system, was a mystic saint, scholar and philosopher of the 16th century (1598-1671 AD) who had immense "Yogic powers" with which he cured millions of people from their worldly miseries and diseases and showed the way to spiritual upliftment.

Sri Raghavendra Swamiji entered Brindavan (Samadhi) alive at Mantralaya in Andhra Pradesh on the second day of Sravana Masa, Krishna paksha, Shaliyana shaka 1593, Virodhikrita Samvatsara and sitting in "Yogic Mudra" inside the Brindavanam, Sri Swamiji still responds to the call of his disciples and fulfills their cherished desires. Millions of such mystical experiences of the devotees record even today. 5. BENEFICIARIES:

5.1 The beneficiaries of this Trust are the general public and it is hereby made clear that the benefits of this Trust shall be open to all sections of the public.

OBJECTS OF THE TRUST: The aims and objects of the Trust shall be:-

To establish, create and manage Educ. inst. institutions for learning from Nursery to College level education including Technical Education, Professional or Vocational courses, Pharmacy, Medicine, Arts, Science, Literature, Computer Education etc., and any other courses which are useful to the general public.

6.2 To open, form, establish, promote, set-up, run, maintain, assist, finance, support, running of residential schools, hostels, boarding houses, dispensaries for children, child welfare centers, and other similar institutions.

6.3 To establish research centers and institutions for promotion of research in the field of education including in the fields of Vedas, Upanishads, Philosophy, Logic Science as also Technical and Medical Education.

- 6.4 To open and establish libraries, reading rooms and vocational institutions.
- 6.5 To grant, pay, give scholarships, stipends, prizes, rewards, allowances and other financial assistance to students who have good track record in the Institutions run by this Trust with a view to help them in promoting their studies in schools, colleges and educational institutions, technical institutions and other training and research work in India or abroad.
- 6.6 To create facilities for working in co-ordination, co-operation and co-operation with other institutions and colleges, bodies or authorities constituted or founded for the purposes similar to this trust.
- 6.7 To publish books, literature on all aspects and curriculum, journals, pamphlets, periodicals and newspaper for the spread and advancement of education and culture.
- 6.8 To setup and maintain Educational Institutions for mentally retarded and physically handicapped.
- 6.9 To provide fees, books, equipments, free ships, and /or scholarship to deserving students and to promote charity by helping deserving and needy students either financially or otherwise.
- 6.10 To conduct seminars, workshops and arrange special lectures or training for students.
- 6.11 To associate with other trusts and societies registered under the Income Tax Act and other organizations in order to achieve the objects of the Trust.
- 6.12 To extend necessary and possible help for the established institutions carrying on any of the aforesaid charitable works and deeds and to provide all or any facilities & equipments to any or all the institutions referred to in any or all of the above objects.
- 6.13 To promote such other objects not inconsistent with the spirit of the trust as the trustees may deem fit with the prior permission under the Income Tax and other laws.
- 6.14 To do or carry on any other lawful activities which may be incidental or ancillary to the attainment of the above objects of the trust.
- 6.15 The Board of Trustees shall have power to enlarge and add to the scope of educational and other activities of the trust including the area of services.


Smt.Sudha.N.Murthy shall be the Life Trustee and the Vice-Chairman of the Trust during her life time.

- 7.4 The Secretary and Treasurer of the Trust shall be appointed by the Board of Trustees out of the remaining Trustees on the Board. The Secretary and Treasurer so appointed shall occupy their positions as Secretary and Treasurer for a maximum period of three years.
- 7.5 The office bearers may be re-elected to the post, if the majority of the trustees so wish.
- 7.6 The Life Trustees of this Trust are entitled to appoint at any time additional trustees of the Trust by co-opting other men or women of their choice to the Board of Trustees.
- 7.7 Every trustee shall be at liberty to resign, by giving one month's notice of his/her intention to do so in writing without assigning any reason. He/She shall hand over the trust property under his/her control immediately to the board of trustees.
- 7.8 Any Trustee acting against the interest of the trust may be expelled by the board of trustees by at least three fourths majority.
- 7.9 The aforesaid Trustees have signed this Deed in acceptance of the office assigned to them.
8. TRUST FUNDS & PROPERTIES:
8.1 The Trustees shall stand possessed of the initial corpus of Rs. 10,000/- [Rupees Ten Thousands only] settled under this trust deed and such further addition to the corpus or donations, voluntary contributions, subscriptions or legacies in cash or kind, as may be invited and received or received without invitation or accepted by the Trustees from time to time from any person or persons, institutions, government or members of public, and all accretions thereto and income thereof. All these receipts shall be treated as forming part of the trust fund being the subject matter of these presents.

9. ADMINISTRATION OF THE TRUST:

9.1 Except as otherwise provided herein, the trustees may meet as often as may be necessary for the conduct of the business of the trust, but at least four times in a financial year. There shall be a meeting to approve the audited financial statements and the audit report and to record the activities of the trust annually.

9.2 The decisions with regard to the management of the affairs of the Trust shall be taken by a simple majority decision of the Trustees present and voting either at a meeting or by circulation of papers or through emails. In all such proceedings the Chairman shall preside over the meetings of the Board of Trustees. In the absence or inability of the chairman to preside over any meeting, the chairman will nominate one of the trustees to preside over the meeting. If the chairman is unable to nominate, the trustees present shall appoint one of the trustees to preside over the meeting and conduct the process.



- 9.3 The Chairman shall have the control of the affairs of the trust and he shall overview the functions and management of the trust; including financial functions.
- 9.4 The chairman or the secretary duly authorized by the chairman, shall give 7 (seven) clear days notice for the meetings of the trust; however chairman or the secretary duly authorized by the chairman shall have the power to convene a meeting with shorter notice for transacting any business considered by them to be urgent.
- 9.5 The business of the trust may also be transacted by circulation of papers or through emails.
- 9.6 The quorum for a meeting of the board of trustees shall be two. For want of quorum, the meeting is to be adjourned for half an hour and immediately thereafter the meeting is to be reconvened subject to the presence of a minimum of trustees.
- 9.7 The chairman who presides over the meeting or in his absence any other trustee, who presides over a meeting as stated supra, shall be entitled to exercise the casting vote in the event of equality of votes at the meeting.
- 9.8 The Secretary shall cause to be maintained, a minutes book in which the minutes of the meetings of the board of trustees, shall be recorded. The minutes shall be approved by the chairman in the next meeting of the board of trustees and shall be duly signed by all the trustees present at the previous meeting. Action taken reports if any shall also be placed before the next meeting in respect of the decisions taken in the previous meetings.
- 9.10 The Secretary shall be the sole custodian of the minute's book & the Treasurer shall be the sole custodian of the books of accounts, cash balance & cheque book.
- 9.11 The accounting year of the Trust shall be from 1st April to 31st March.
- 9.12 The Trust shall be non-political in nature.
- 9.13 The Trustees shall constitute a governing council for strategic long term planning and good governance of the institutions run by the Trust in accordance with the rules or bye-laws to be framed in this regard. Such persons shall be persons of eminence selected by the Trustees from the field of education, administration, science, technology and others. The function of the governing council shall be only advisory in matters relating to organization, management and administration of the schools and colleges. The board of Trustees is also authorized to constitute such other advisory bodies or committees as may be required for the smooth and efficient running of schools or colleges run by the Trust.

9.14 The Secretary and Treasurer shall cause to be kept wherein shall be entered a true and accurate account of all monies received, disbursed, or spent in connection with, or in the course of, management of the said Trust Fund and its properties or in relation to the carrying out of the objectives and purposes thereof, as well as of all the assets, liabilities and effects of the Trust Fund. The accounts shall be audited by a Chartered Accountant to be appointed by the Board at a meeting of the Board of Trustees.

10. POWERS OF THE BOARD OF TRUSTEES.

For carrying out the objects of the trust, the trustees shall have the following powers:

10.1 To accept any donations, contributions, grants, gifts, endowments and / or subscriptions either in cash or in kind from any persons, association of persons, corporate bodies, trusts, institutions, union & state governments, corporations, local bodies etc. The Trustees may invite, receive, or accept any property or properties, movable or immovable, in cash or kind, as capital endowments or addition to corpus and may also invite, receive or accept voluntary contributions or donations or subscriptions, or legacies, in cash or in kind, to have and to hold all of them in to the Trustees forever upon trust for the purposes of the Trust and such capital endowment or addition to corpus or voluntary contribution or donation or subscription or legacies shall be treated as the property of the Trust hereby constituted;

10.2 The trustees may decline to accept any offer of any capital endowment or addition to corpus or donation at their discretion without assigning any reason.

10.3 To acquire and purchase, lease, exchange, gift, hire or transfer and / or deal otherwise with any land, building, and other properties, moveable or immovable, including machinery, equipment or estate or interest and to hold, develop, improve or maintain the same.

10.4 To apply the whole or any part of the income of the trust, or the trust fund or accumulations thereto, towards any one or more of the objects of this trust as the case may be, at their discretion as they deem fit from time to time.

10.6 To borrow funds either with or without security as per Law prevailing at that time.

10.7 To sell, dispose of, alienate or otherwise deal with any trust properties as per law applicable at that time.

10.8 To grant on lease, hire or otherwise deal with the properties of the trust.

10.9 To decide all matters relating to the scope, objects and purposes of the trust.



- 10.10 To determine, sanction and allot recurring and non-recurring expenditure of the trust and / or institutions created and established under the trust and to direct and approve capital expenditure and other expenditure.


15. DISSOLUTION:
